FRESNO YOSEMITE INTERNATIONAL AIRPORT TARMAC DELAY CONTINGENCY PLAN

Fresno Yosemite International Airport has prepared this Tarmac Delay Contingency Plan pursuant to 49 U.S.C. § 42301. Fresno Yosemite International Airport is filing this plan with the Department of Transportation because (1) it is a commercial airport or (2) this airport may be used by an air carrier described in 49 U.S.C. § 42301(a)(1) for diversions.

This plan describes how, following excessive tarmac delays and to the extent practicable, Fresno Yosemite International Airport will:

- Provide for the deplanement of passengers;
- Provide for the sharing of facilities and make gates available at the airport; and
- Provide a sterile area following excessive tarmac delays for passengers who have not yet cleared United States Customs & Border Protection (CBP).

Plan to Provide for the Deplanement of Passengers Following Excessive Tarmac Delays

Fresno Yosemite International Airport has limited equipment and personnel needed to safely deplane passengers from air carrier aircraft. We will utilize this equipment to deplane passengers as soon as practicable after receiving requests from such airlines at the contact number listed above. We will also provide a list of airlines, ground handlers, fixed base operators and others who may have the necessary equipment and personnel to safely deplane passengers to airlines as soon as practicable after receiving requests from such airlines experiencing excessive tarmac delays at the contact number listed above.

Plan to Provide for the Sharing of Facilities and Make Gates Available in an Emergency

The gates at Fresno Yosemite International Airport are under common use gate leases, permits, or agreements to air carriers and are controlled by the airport. We direct our common use air carrier users to make gates and other facilities available to an air carrier seeking to deplane at a gate to the maximum extent practicable. Aircraft larger than B757 may need to deplane remotely.

Plan to Provide a Sterile Area for Passengers Who Have Not Cleared United States Customs and Border Protection

Fresno Yosemite International Airport has defined sterile areas capable of accommodating limited numbers of international passengers. We will coordinate with local CBP officials to develop procedures that will allow international passengers who have not yet cleared United States Customs and Border Protection to be deplaned into these sterile areas to the extent practicable.

Public Access to the Emergency Contingency Plan

Fresno Yosemite International Airport will provide public access to its emergency contingency plan through one or more of the following means:

- Providing notice of the availability of the plan on the airport's social media accounts.
- Posting signs in conspicuous locations in the terminal
